HIGHLIGHTS

A New Normal

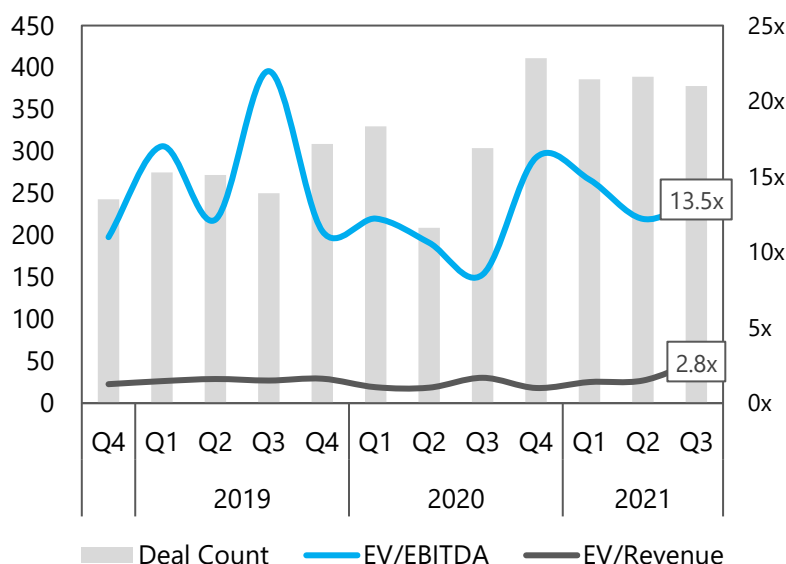
The long-tail echo of the pandemic has perversely affected many industries. Leaders in Consulting and IT Services, however, have reacted with a sustained effort to meet the accelerating trends of digitization, cloud-enablement, and big-data fluency that have emerged with force over the past six quarters. Large incumbents like Accenture, IBM, and **Deloitte** have competed with record levels of private equity dry powder deployed by firms like The Carlyle Group, Berkshire Partners, and Blackstone to acquire smaller but promising IT services businesses with talent and expertise in cloud, ERP systems, and AI, among many others.

Many dealmakers view tech M&A as essential to transforming existing offerings, back-filling capabilities, and expanding into new markets.

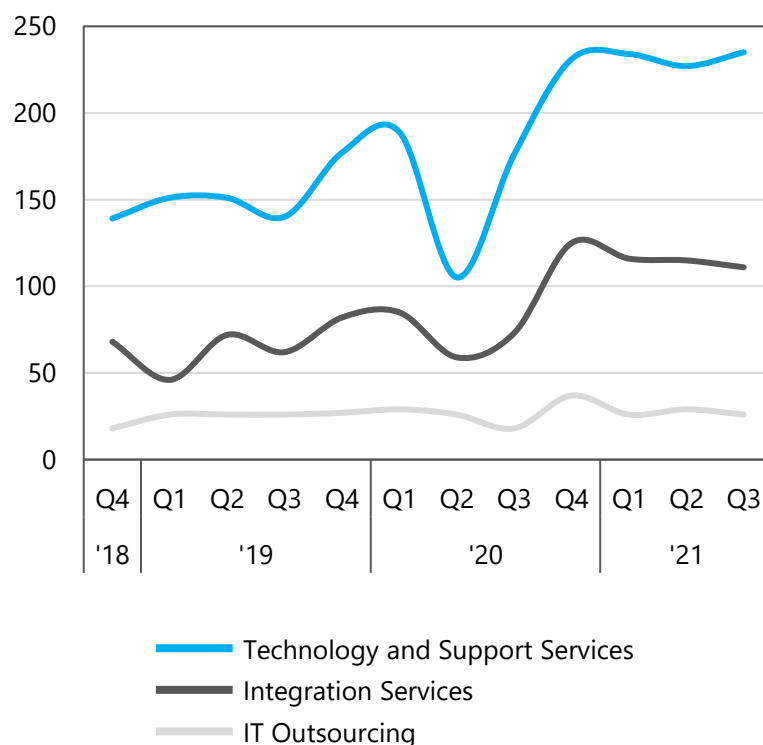

M&A deal levels across the sector as well as in our three key IT Services verticals have established a new normal compared to pre-COVID levels. This has largely been driven by serial acquirers looking to diversify their product offering or protect their economic moat. While M&A activity seems as though it has reached a peak, we believe there is still room for deal counts, multiples, and optimism in the IT Services sector to escalate as we look towards 2022, barring a deeply disruptive resurgence of COVID or over-burdensome regulatory scrutiny.

IT Services PE Buyouts & Strategic M&A Deals

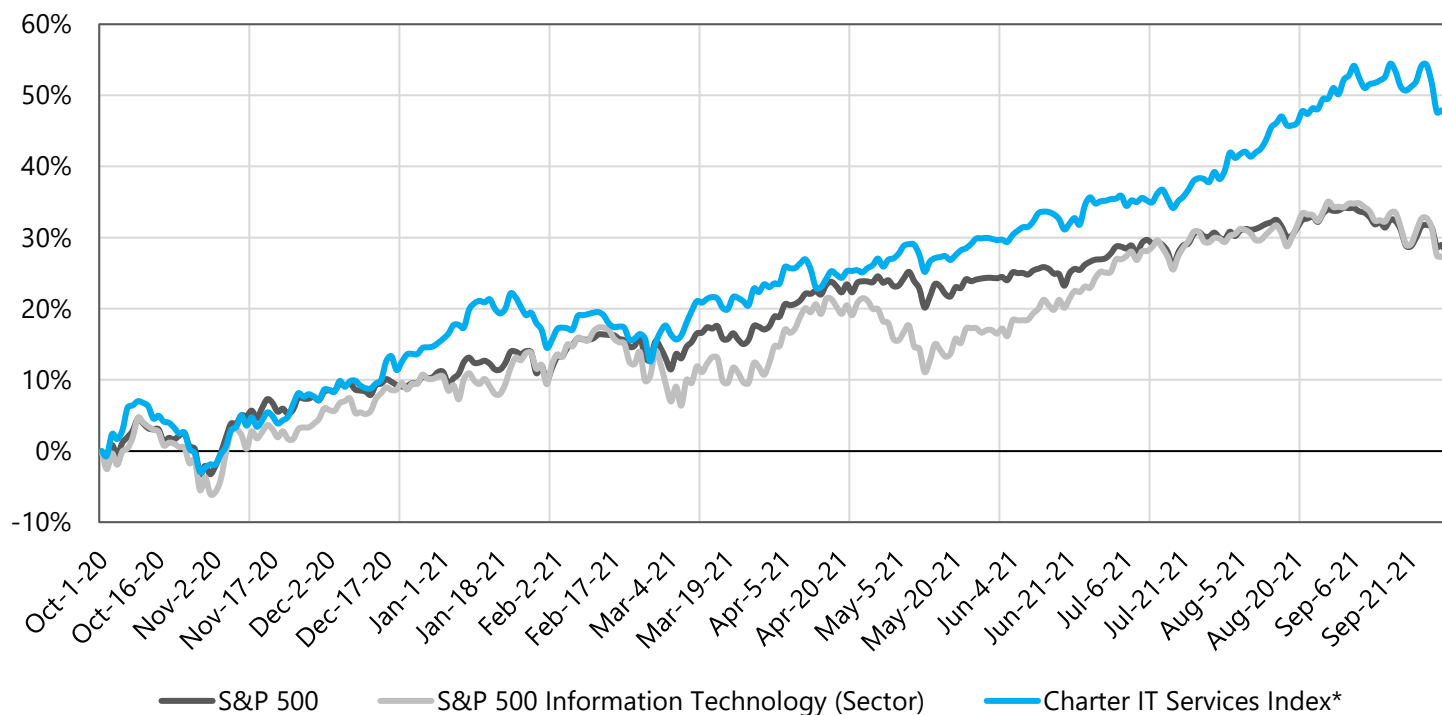


Quarterly Deal Volume by Vertical

IT Services Share Prices Soar

HCL Technologies (NSEI:HCLTECH), an India-based IT services and consulting company, led the Charter IT Services Index upward during Q3 with a 29.8% quarterly gain as the company rides the ongoing wave of accelerating demand for digital and cloud offerings. The Q3 runner up in the index was Gartner (NYSE:IT) who has now posted four consecutive quarters of 10%+ share price growth.

Two other big winners during Q3 were Greensky and Affirm, both players in the “buy now pay later” (BNPL) vertical. Greensky’s share price surged upward in response to Goldman Sachs announcement that they will be acquiring the company for \$2.2B. BNPL has rapidly gained popularity among e-commerce companies and small businesses. Some might view this level of consumer credit availability, in combination with recent federal stimulus packages, as a sign that the economy has over-heated and needs cooling off.
